In consideration for being allowed to participate in the Event, We agree as follows:

1. I and/or my child or legal charge (hereinafter referred to as "We") desire to participate in an event sponsored by Calvary Chapel of Albuquerque, Incorporated, a New Mexico nonprofit corporation (hereinafter "Calvary") known as "Turn Us Loose" (the "Event"). We understand that participation in the Event could result in injury. We choose to voluntarily participate in the Event activities at our own risk. (All activities involved in the Event are collectively referred throughout this agreement as the "Accepted Activities"). By this agreement, we relieve and release Calvary, its staff and volunteers, of any duty to us with regard to the Accepted Activities and We do hereby assume the entire risk of any injuries or damages that might occur as a result from the Accepted Activities or our use of or presence at the Calvary facilities. By this agreement, We also discharge and absolve Calvary, its staff and volunteers from any liability for any active or passive negligence whatsoever (including, but not limited to, any liability for negligent maintenance and negligent supervision) by Calvary, its staff and volunteers, and do waive and relinquish any claim or action against Calvary, its staff or volunteers for any loss, claim, damage, personal injury, disability, death, medication, and any other type of expense or property damage or loss (collectively referred to throughout this agreement as "Damages"), caused by any negligence of Calvary, its staff or volunteers and promise and covenant not to sue or exercise any legal right to seek damages from Calvary, its staff or volunteers.

2. As to participation in any activity, including but not limited to, the Accepted Activities and as to any and all liability for any Damages that We may suffer or incur due to any cause whatsoever, We hereby agree to:

- a. waive any and all claims for damages that we may have against Calvary, its managers, ministers, volunteers, employees, officers, associates, agents, builders, vendors, bands, exhibitors, or any other person or company in any way associated with Calvary;
- b. release Calvary from any and all liability for any Damages that We may suffer or incur, or that my next of kin may suffer or incur as a result of our participation in any activity, including but not limited to, the Accepted Activities; and,
- c. hold harmless and indemnify Calvary from any and all liability for any Damages to any third party resulting from our participation in any activity, including but not limited to the Accepted Activities, except to the extent such indemnity is prohibited by law.

3. This waiver and release of liability and indemnification agreement (collectively referred to hereafter as "Waiver and Release") shall be effective and binding upon our heirs, next of kin, family, relatives, guardians, conservators, executors, administrators, trustees, and assigns in the event of any injury, disability, disease or death.

4. We hereby verify that the participant in the Event is over 18 years old or if the participant is under 18 years old, then this agreement is being executed by the parent or legal guardian of the participant on behalf of himself/herself and the participant. We have completely read and understand this Waiver and Release and its terms. Prior to signing this Waiver and Release, We had opportunity to ask any questions about the Waiver and Release and about the Event. We are aware that by signing this Waiver and Release, We assume all risks and waive and release certain rights that We, our heirs, next of kin, relatives, guardians, executors, administrators, trustees, and assigns might otherwise have in the event of injury, disability, disease, or death.
